- 3.) All bids shall be entered on the **provided** Bid Tab sheets enclosed or a copy thereof. Bids are to be typewritten or in ink and legible. No bidder may withdraw his proposal for a period of thirty (30) days after the date and hour set for the opening of bids.
- 4.) The bidder shall attach the manufacturer's name of the equipment or material to be furnished, type, model numbers, manufacturer's descriptive bulletins and specifications. All guarantees and warranties should be clearly stated. This data shall be in sufficient detail to describe accurately the equipment or material to be furnished. - 8.) Firm prices will be F.O.B. destination.
- 9.) Unit prices will be guaranteed correct by the bidder.
- 10.) This bid is submitted as a legal offer and any bid when accepted by the County constitutes a firm contract.
- 11.) This particular bid (commonly referred to as "the six-month bid") establishes base pricing by unit of measure, valid for a 6-month period on a variety of materials used in the construction and maintenance of the McIntosh County Road system. Those materials are listed and broken out by category within the attached McIntosh County 6 Month Items for Bid packet that has been provided with the invitation to Bid notice. Material and Product Categories are marked by Item Number for your use and to allow for you to provide an effective bid.
